Event description:	

The third theme based training of teaching staff for acquiring new teaching and learning methods of the Erasmus+ CBHE project "Strengthening of master curricula in water resources management for the Western Balkans HEIs and stakeholders" (SWARM) was held at the University of Rijeka, Faculty of Civil Engineering (UNIRIFCE) from 18<sup>th</sup> to 20<sup>th</sup> September 2019. All WB project partners took part at this training.

Seventeen representatives from 8 partner institutions were present at the training (15 out of 23 were from WB partner HEIs – UNI, UNS, UNSA, UNMO, UPKM, TCASU and UoM).

#### First day

After the participants' registration, which started at 09:30, Ivana Štimac Grandić, dean of Faculty of Civil Engineering, welcomed everyone. Barbara Karleuša, contact person at the UNIRIFCE for the SWARM project, presented the agenda and welcomed participants. Nevenka Ožanić presented University Campus and laboratory development and highlighted the need of similar projects for the improvement of WB HEI's capacity. Barbara Karleuša presented UNIRIFCE studies related to WRM. Next two presentations were oriented to the quality assurance and monitoring (QAM). Aleksandra Deluka Tibljaš presented QAM at the university level while Barbara Karleuša presented at the faculty level. Both of them highlighted the need for corrections in learning methods and curricula accepting QAM results.

Nevena Dragičević and Barbara Karleuša presented the course "Water resources management" (master study) and models of master thesis preparation in WRM courses.

All participants of the SWARM project had special training on e-learning in WRM provided by Nino Krvavica. He explained how to use Google classroom in teaching purposes.

The first training day finished at 16:00.

#### Second day

The participants' registration started at 09:30. Josip Rubinić explained issues in WRM in Croatia in climate change context. WRM should be adapted in line with the climate changes. Igor Ružić presented his team experience in WRM applying innovative and scientific approaches. Goran Volf presented assessment of proper wastewater treatment level according to marine ecosystem state.

The second day finished at 12:30.

#### Third day

The third day started at 13:00 after Project Management Committee meeting. All SWARM staff had practice teaching, i.e. tour to the Laboratory of Hydrotechnics. Vanja Travaš, Elvis Žic, and Goran Volf presented the use of laboratory and equipment in teaching and preparation of graduation thesis, research and professional work.

The third day finished at 16:30 with the general discussion and closing remarks.




