At the meeting, participants were introduced with the main objectives of the SWARM project and modernized courses at the Department of Hidrotechnics UNSA FCE developed under the SWARM project. Emina Hadžić explained to participants the structure and the learning outcomes of the modernized study programmes.

After that, Emina Hadžić, Suvada Šuvalija, Hata Milišić, Suada Sulejmanović, Ammar Šarić talked about water management and adaptation to climate change. Emina Hadžić introduced the EU Water Policy under the Water Framework Directive, while Hata Milišić presented EU best practices in the water sector. The topic of general discussion was implementation of EU Water Framework Directive in the water sector in Bosnia and Herzegovina.

Participants expressed the interest for modernized master programme and concluded that future graduated students will have opportunity to work on water quality programme and in general in the civil engineering sector. The final remarks were regarding the possible cooperation with present companies and UNSA.

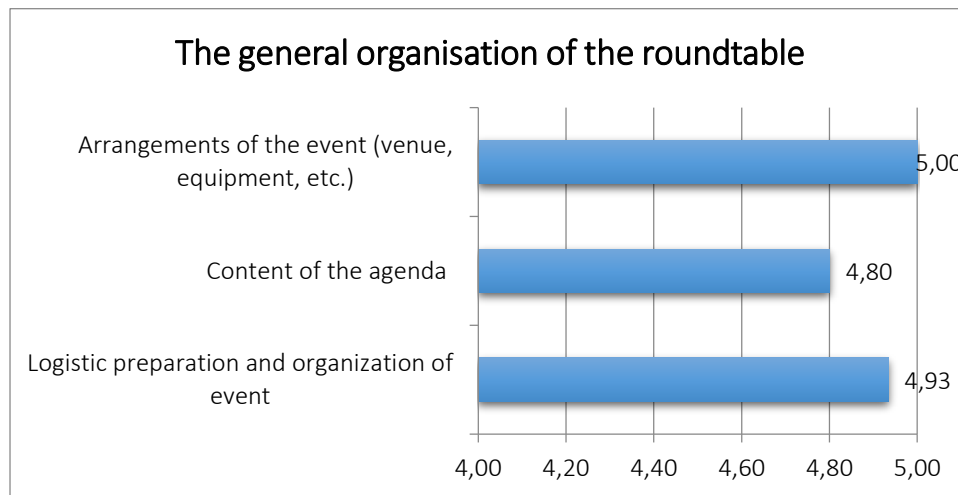

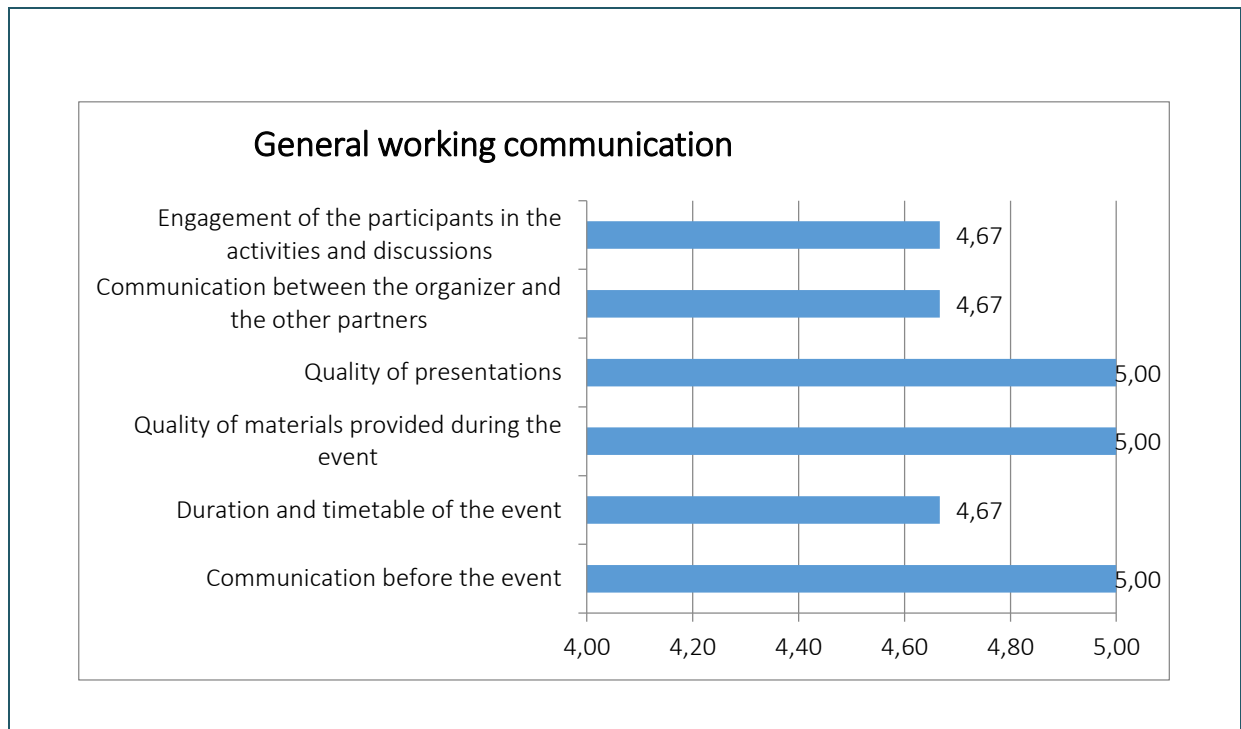

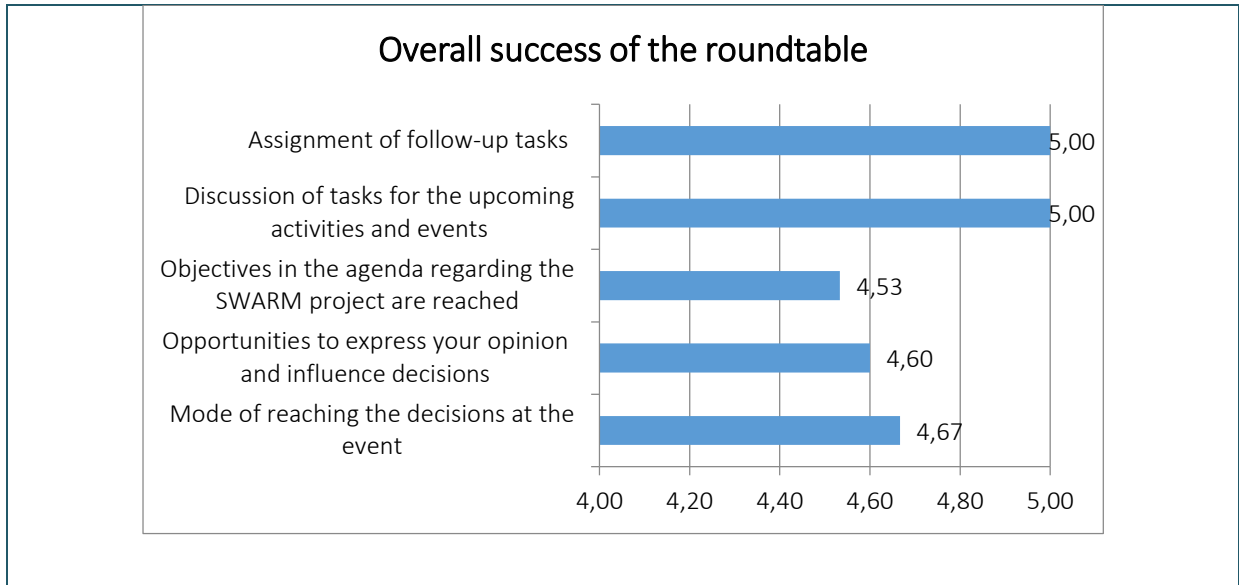
